## Important Reminders:

- Indoor 4-H exhibits (except nutrition/baking) are to be delivered to the Fairgrounds on Saturday, August 12<sup>th</sup>, 9am-3pm. Nutrition/Baking exhibits are to be delivered to the Fairgrounds on Monday, August 14<sup>nd</sup>, 4pm-6:30pm or Tuesday, August 15<sup>rd</sup>, 7:30am-9:30am. All exhibits will be released on Sunday, August 20<sup>th</sup>, 8am-10am.
- Pre-register any indoor exhibits you think you might bring to the fair. There will not be a penalty if you do not bring a pre-registered exhibit. Changes may be made while entries are being taken.
- It is important for all 4-H exhibitors to read through the 4-H Exhibits Department section. - Remember: posters, display boards, vertical displays, project specific boards, and photography exhibits all have specific size rules that can be found in the rules and classes. Also, 4-H'ers must be enrolled in the respective projects for exhibits entered.
- A 4-H member must be in good standing with their 4-H Club to be eligible to enter indoor 4-H exhibits.
- All exhibits must be the work of the exhibitor and completed during the current 4-H year ('16-'17). The '16-'17 4-H year began on October 1, 2016 and will end on September 30, 2017.
- Please label all exhibits with your name and class number in an inconspicuous spot (example: place a label on the back of your posters with your name and class number).
- All rules will be enforced and if you have any questions regarding indoor 4-H exhibits contact the Extension Office, 437-0231.
